#### **POSITION PURPOSE**

The primary purpose of the Leader, Radiation Instrument Calibration is to lead/coordinate a team of Radiation Instrument Calibration Technicians to provide timely and accurate calibrations of radiation protection instruments for ANSTO and external commercial clients to ensure compliance with regulatory requirements.

#### ORGANISATIONAL ENVIRONMENT

The Radiation and Nuclear Waste Services business provides a wide range of radiation safety related consulting and delivery of services for ANSTO and external organisations. This includes specialised advice and services related to radiation protection consultancy, instrument calibration and radiation safety training services. In addition, the business provides nuclear waste management solutions to external clients, generating commercial revenue for ANSTO.

#### **ACCOUNTABILITIES & RESPONSIBILITIES**

#### **Key Accountabilities**

- Liaise with both internal and external clients to schedule and prioritise calibrations, including issue of quotes and ensuring that purchase orders are correctly processed for commercial revenue generation.
- Allocate calibration work to technical staff and monitor performance against KPI's to ensure regulatory requirements and revenue forecasts are met.
- Provide coaching, training and mentoring to technical staff in calibration system operations and instrument calibration techniques as well as conducting demonstrations of calibration facility operations to training course participants and other visitors to the facility.
- Analysis and technical understanding of instrument manufacturer's specifications, develop and implement applicable traceable calibration protocol within an ISO 9001 Quality Management System.
- Manage and operate multiple purpose-built instrument calibration systems in accordance with relevant operations manuals and work instructions. Ensure all safety interlocks are checked and operational on a daily basis.

- Acquire and utilise an understanding of the functions and operation of all instruments requiring
  calibration, including adjustment methods and software communication. This includes knowledge of
  type and energy of radiation detected, units displayed, scales and ranges of measurement, efficiencies
  of detection, location of detectors inside instruments and any precautions issued by the manufacturer
  on the use of the instrument.
- Problem solve new and reoccurring instrument calibration issues, conduct testing and apply the appropriate course of action to ensure accuracy and linearity.
- Supervise and approve the issue of accurate, traceable and detailed calibration reports for all calibrations conducted.
- Assist with management of the Calibrations Group and Facility in the absence of the Calibration and Specialist Support Manager.
- Undertake additional duties as required.

## **Decision Making**

- The position works within a framework of radiation legislation, policies, professional standards and resource parameters. Within this framework the position has some independence in determining how to achieve objectives of the service deliverables to match the needs of ANSTO and Commercial customers, including deciding on methods and approaches.
- The position determines key work priorities for their team within the context of agreed work plans and will consult with the Manager on complex, sensitive and major issues that have a significant impact on the customer group or ANSTO regulatory compliance.
- The levels of authority delegated to this position are those approved and issued by the Chief Executive
  Officer. All delegations will be in line with the ANSTO Delegation Manual AS-1682 (as amended or
  replaced).

## **Key Challenges**

- Developing skills and knowledge of technical staff in the operation and calibration methods of radiation monitoring instruments.
- Scheduling workload where there are multiple customer requirements and conflicting priorities requiring to be completed within tight timeframes.
- Ensuring work is to a high standard and fully complies with a wide range of technical, safety and quality standards, regulations and procedures.
- Communicate clearly and effectively with people of various levels of technical understanding within and outside of ANSTO.
- Maintaining knowledge and application of technical developments in radiation detection equipment and related software interfaces.
