POSITION PURPOSE

The primary objective of the Senior/ Project Manager is to lead and manage large, multi-disciplinary projects, that meet customer requirements from concept through to development, manufacturing, testing, commissioning, and completion, ensuring conformance with processes and regulatory procedures.

ORGANISATIONAL ENVIRONMENT

ANSTO leverages great science to deliver big outcomes. We partner with scientists and engineers and apply new technologies to provide real-world benefits. Our work improves human health, saves lives, builds our industries and protects the environment. ANSTO is the home of Australia's most significant landmark and national infrastructure for research. Thousands of scientists from industry and academia benefit from gaining access to state-of-the-art instruments every year.

ANSTO in Victoria develops ANSTO's presence in Victoria and supports ANSTO's mandate to provide nuclear science and technology for public benefit. At ANSTO's Clayton campus, the Australian Synchrotron is landmark scientific infrastructure that enables the characterisation of hard and soft materials and living tissues for structure, function and clinical investigations for industry, health, food, environment, biotechnology, nanotechnology, energy, advanced materials and heritage/archaeology research sectors.

The Australian Synchrotron operates as a platform within the ANSTO's Nuclear Science & Technology and Landmark Infrastructure (NSTLI), which incorporates ANSTO's research, innovation, landmark research infrastructure and associated platforms and capabilities. The Australian Synchrotron's ten world class beam lines, three of which are world leading, enable experiments not possible with conventional X-Ray sources. The Australian Synchrotron collaborates with a wide range of research groups across Australian and New Zealand Universities, Research Institutes, ANSTO, CSIRO, museums, international research organisations and interacts with Australian and international companies in the Medicine, Mining, Pharmaceutical, Biotechnology, Nanotechnology, Agriculture and Energy industries.

The Project / Senior Project Manager role sits within the Project Management Office function. The function is responsible for the strategic infrastructure planning, oversight of project management and for the delivery of large, complex, multidisciplinary, strategic programs and projects, requiring ANSTO Executive stakeholder involvement and regulatory interaction.

ACCOUNTABILITIES & RESPONSIBILITIES

Key Accountabilities

- Manage multi-disciplinary projects from conception to completion, including scope management, supervision, cost control, time management, quality/ safety/ environmental control, and contract management, ensuring work is delivered on time and budget.
- Initiate projects including consulting with clients, stakeholders and management to gain acceptance of business cases. This includes developing cost benefit analyses of proposed options, seeking new solutions, and developing new techniques and methods.
- Manage multi-disciplinary project teams including frequent communication, conflict resolution and negotiation.
- Provide quality verbal and written reports and presentations to stakeholders including the ANSTO executives.
- Undertake detailed project planning including developing a project plan to deliver the project either based on approved funding or in order to attain funding.
- Manage project risk by proactively tracking cost forecasting, task scheduling, contract administration and resolving critical issues.
- Manage customer relationships and ensure customers are informed of progress of project.
- Undertake additional duties as required and during period of leave of other staff.

In addition to performing all Band 6 key accountabilities, the key accountabilities for a Band 7 position include:

- Independently and concurrently lead multiple large projects and multi-disciplinary teams, typically
 of higher complexity
- Coaching and mentoring of staff including sharing of specialist knowledge
- Deliver client focused solutions with the ability to influence, negotiate and liaise with senior staff including developing reports for the Executive, CEO and Board.
- Influencing and managing subject matter experts

Decision Making

- The ANSTO values, organisational corporate plan, business plan, operational excellence program, the Research Translation and Australian Synchrotron strategy and PMO business objectives provide the context for the position.
- The position works within a framework of legislation, policies, professional standards and resource parameters. Within this framework the position has some independence in determining how to achieve objectives of the unit, including deciding on methods and approaches, operations, and project planning.
- The position is fully accountable for the accuracy, integrity and quality of the content of advice
 provided and is required to ensure that decisions are based on sound evidence. At times, the
 position may be required to make effective judgements under pressure or in the absence of
 complete information or expert advice.
- The levels of authority delegated to this position are those approved and issued by the Chief Executive Officer. All delegations will be in line with the ANSTO Delegation Manual AS-1682 (as amended or replaced).

Key Challenges

 Managing quality, budget, schedule and resources to simultaneously deliver multiple large projects that can be impacted by external factors;

- Ensuring successful implementation and project completion whilst managing conflicting interdependencies, priorities and deadlines;
- Meeting the requirements and expectations of multiple stakeholders where there may be conflicting priorities.
